3.- OBJETIVOS GENERALES:

- To include housing in a wider theoretical discussion of current urbanization. The course will discuss new forms of urbanization and will challenge the idea promoted by United Nations Habitat of an "urbanized world". The argument to be explored concerns the epistemological foundations of critical urban theory and practice. This innovative view of "the city" from another angle, will allow students to understand the hidden impacts of the city on the rest of the territory.
- Language matters, so this course will also analyze the wider array of concepts that are used to refer to the dwellings and habitats of low-income populations. The use of apparently well meaning concepts such as "affordable housing", "inclusion", "density" and "diversity", can in fact be another way of encouraging social injustice and further inequality.
- To discuss current tendencies and prospects for low-income housing and habitat. Access
 to housing for low- income populations is not the same as it was at the turn of the century.
 Are the poor being pushed out of the city? What is the new configuration of low-income
 residential areas in the city? Do those who inhabit existing low-income settlements have
 any hope of improving their living conditions?

5.- DESCRIPCIÓN Y CONCEPTUALIZACIÓN DEL CURSO.

The seminar provides the students with new ideas about current trends of thought on urban theory and challenges commonly used concepts. Through readings and discussions students are introduced to developing a critical view of "the new urban world", and the increasingly difficult situation faced by the low-income groups to find a place to live in the city.

6.- METODOLOGÍA DE TRABAJO Y/O ACTIVIDADES PARA EL ALUMNO.

The five units of the course will be taught at the classroom. The professor will present the main topic at the beginning of the session, and then the active participation all the students is required in a discussion of the topic allocated to each unit. At the beginning of the first four sessions, all students should have a printed report of the reading (two pages, Times New Roman, 12p, 1.5 spaces). It will include the main arguments of the reading material designated for that unit. In the last session, students will hand in a short work (written, video, etc.) reflecting on any of the main topics of the seminar, using the reading material provided and any other relevant bibliography.

It is important that all students arrive on time. Only one justified absence is allowed, and three late arrivals (after 10 minutes) constitute one absence. Reading reports are handed in each session, backdated reports are not accepted, and longer or shorter reports than the stipulated two pages will not be marked. The final evaluation will be as follows: 30% Participation, 40% Reading Reports (4), 30% Final Report.
